

## Certified Community Bank Director Program

The Certified Community Bankers Designation (CCBD) is a collaboration of and administered by the Independent Bankers Association of Texas (IBAT) and the SW Graduate School of Banking Foundation (SWGSB). This certification covers not only the regulatory and fiduciary responsibilities of bank directors, but also board processes and structures. In addition, the program focuses on what makes boards and directors effective as well as what is expected of them by regulators, examiners, and shareholders. Upon completion of all requirements, participants will be awarded a certificate and be allowed to use the CCBD designation. Requirements include additional education and signing of a code of ethics. The CCBD Program is for new directors, including those new to banking, as well as experienced directors looking to be certified on core director responsibilities and liabilities.

## Assemblies for Bank Directors

The Assemblies for Bank Directors gather directors from throughout the country to discuss the latest updates on issues and strategies affecting the industry.
